### **Lord Mayor's Programme**

### Funeral of Her Majesty Queen Elizabeth II

Like all Members, I have been deeply saddened by the death of Her Majesty Queen Elizabeth II. The City of London, the nation and the Commonwealth has been immeasurably fortunate to have enjoyed more than seven decades under a Sovereign whose selfless dedication to duty has been both a blessing and an example. The City has long enjoyed a close and warm relationship with the monarch, and we had an opportunity to celebrate Her Majesty Queen Elizabeth's reign at the Platinum Jubilee events at St Paul's Cathedral and Guildhall in June and since the death we have had further cause to reflect and give thanks for her life. We have played our own part in some of the major events that have marked this momentous change. On Saturday 10 June, with the Sheriffs and the Recorder of London, I attended the first part of the Accession Council at St James's Palace, before welcoming the Clarenceux King of Arms, with the Heralds and Pursuivants, for the customary Accession Proclamation from the steps of the Royal Exchange. It is a testament to the work of colleagues across the City of London Corporation and the City of London Police, over many years, that the arrangements went so well and the ceremony, which was watched by many millions around the world, was so impressive and dignified. I send my appreciation to all Members and Officers who worked on any aspects of operation London Bridge – whether it has been delivering the ceremonial aspects or co-ordinating security, road closures, crowd management and public information services. I feel confident that we did Her Majesty proud. We now look forward to supporting His Majesty King Charles III in the task to which he has been called.

### Visit to India

The Lord Mayor visited India from 21–23 September, spending two days in Mumbai and a day in Bangalore. It was the first in-person visit to the country since 2019 and took place against the backdrop of ongoing Free Trade Agreement negotiations and the imminent uptake of the G20 Presidency. In both cities the topics of sustainable infrastructure, green finance regulation and fintech particularly resonated. The Lord Mayor was able to deliver a positive pitch for City support to promoting investment flows, whilst gathering information on some of the challenges facing the market and exploring ways in which the UK can offer expertise to help combat these and strengthen the UK-India relationship. In Mumbai, the Lord Mayor had many bi-lateral meetings with senior representatives from industry and government, including with the Reserve Bank of India, Reliance, SEBI and the Minister of State for Finance Dr. Bhagwat Kishanrao Karad. He was also hosted by the Hinduja Group for a lunch to explore points of collaboration and had the opportunity to speak twice at the Global Fintech Festival. His participation at the Festival provided a platform from which to engage with UK fintechs and hear about their India plans, as well as with India-based representatives from key UK financial and professional services firms, with the festival focused on exploring how we can further green infrastructure opportunities. In Bangalore, the Lord Mayor visited Karnataka Digital Economy Mission and Reserve Bank Innovation Hub where he participated in a roundtable highlighting the Bangalore tech offer and exploring possible ways the UK could support this. The Lord Mayor also took part in a Women in Fintech roundtable hosted by Revolut.

### **Cambridge Economic Crime Symposium**

The Lord Mayor attended the Cambridge Economic Crime Symposium. He delivered a keynote speech to a high-profile international audience alongside the Economic Secretary to the Treasury. The speech was focused on the City Corporation's work to tackle economic crime, in support of City of London Police work in this area. Other Members also attended throughout the conference.
